Company History

Founded in 1989

While there was a political turnaround on the world stage, Michael Hörmann opened a new chapter in drive technology in Marienfeld, East Westphalia. Michael Hörmann founded Marantec out of a door drive production that had previously belonged to the door manufacturer Hörmann. The company name is an acronym for Marienfelder Antriebstechnik, but over the past 30 years it has become a household name in the industry all over the world.

Experience since 1957

Even if Marantec is a child of the 80s, the experience of the employees and the company's management goes back much longer. Already since 1957, specialist knowledge has been built up in the door drive production, which belonged to Hörmann at that time.
